From Points North:

95 South to Exit 17 (Elmwood Avenue).
Take a left onto Elmwood Avenue.
Continue straight to the intersection of Elmwood & Park Avenues.
A Mobil Gas Station & St. Matthew's Church will be across the street at this point.
Take a left onto Park Avenue.
Continue straight through several street lights until you come to the intersection of Park & Warwick Avenues.
A Fire Station will be across the street at this point.
Continue STRAIGHT through this intersection.
At the stop sign, take a right onto Broad Street.
Continue straight down Broad Street for approximately 3/4 mile.
The RI Shriners Imperial Room is the brick building on the right, across the street from the Rhodes-on-the Pawtuxet gazebo.

From Points South:

95 North to Exit 16 (Cranston / Elmwood Avenue).
Bear right on the exit ramp.
Take a right onto Elmwood Avenue.
Continue straight to the intersection of Elmwood & Park Avenues .
A Mobil Gas Station & St. Matthew's Church will be across the street at this point.
Take a left onto Park Avenue.
Continue straight through several street lights until you come to the intersection of Park & Warwick Avenues.
A Fire Station will be across the street at this point.
Continue STRAIGHT through this intersection.
At the stop sign, take a right onto Broad Street.
Continue straight down Broad Street for approximately 3/4 mile.
The RI Shriners Imperial Room is the brick building on the right, across the street from the Rhodes-on-the Pawtuxet gazebo.
