A *How to Calculate Rent by Hand*

Calculating rent is in Chapter 5 of the handbook. Historically all calculations were done by hand. But once we came out of Egypt, calculations are now being done by computers and programs from our software companies. And even the CPO exam requires that you calculate rent from a case study (they do allow you to use a calculator and not abacus or slide rule). Re-learn how to do this task and keep it simple. Many maintenance professionals are more than half way on their way to this designation but don't even realize it. In this session, Scott and Jay will explain in layman's terms how you can achieve these prestigious designations. What will this designation do for you? You will be recognized for your professionalism by your current and future employers; owners of the sites you oversee and by the agencies and officials that you come in contact with regularly. You will also have the power and support of a national organization working for you, as well as networking opportunities with other maintenance professionals in the specialized field of affordable housing.
