






Forms of Abuse

- Controlling, isolation, distancing from family
- Threatened about deportation & insecure immigration status
- Visa dependency creates power dynamic & coercive control

Ex: withholding passports & important documents, dangers of deportation if spouse is arrested




These forms are inextricably linked and often appear in combinations.

Domestic Violence Advocacy


- Multilingual DV counseling

Housing & Economic Empowerment Program


- Saheli supports survivors with short & long-term rental assistance, utilities, and other basic needs assistance
