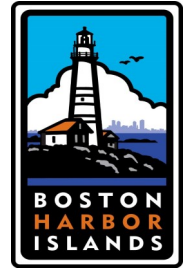

- NEAHMA is only responsible for providing 10 free ferry tickets, for the first 9 management companies that register.

Suggestions:

- Have everyone wear the same color T-Shirt or shirts so you can find each other quickly.
- Please dress appropriately. We suggest kids wear casual clothes and sneakers.
- Activities are mostly outdoors.
- You must have a group leader for every 10 children that will be attending to stay with the youth throughout the day!
- Please bring sunscreen, hats and sunglasses!
- Don't forget a camera!
- **Emergency Contact Information**– group leader should keep this list on them at all times.
- Please bring additional snacks and drinks for your youth to enjoy throughout the day.

There are numerous public parking garages around Long Wharf. The closest is the **Boston Harbor Garage** located at the corner of Atlantic Ave & Milk Street.



The **Aquarium stop** on the **MBTA Blue Line** is the closest MBTA T stop. Alternatively, via the **Orange line**, use the **State Street stop** and walk a few blocks.
