The NAHMA March Meeting is right around the corner! Just a friendly reminder that while in Washington, D.C., make sure your voice gets heard on affordable housing issues important to you by scheduling Hill Visits with your Senators and Representatives and joining our Hill Visit Challenge.

**1. Meet with your lawmakers or their staff on Capitol Hill**

Following the NAHMA meeting, head to Capitol Hill on Tuesday afternoon to visit with your lawmakers or their staff and talk to them about affordable housing management issues that are important to you.
