

NAHMA LIHTC Update: Low-Income Housing Tax Credit Rates for June, 2017

Dear NAHMA Members,

Yesterday, the Internal Revenue Service (IRS) issued **Revenue Ruling 2017-12**, which provides various prescribed rates for federal income tax purposes, including applicable federal interest rates, adjusted applicable federal interest rates, and adjusted long-term and tax-exempt rates for June 2017.

As provided in the ruling, **Table 4** contains **LIHTC Appropriate Percentages Under Section 42(b)(1) for June 2017**:

- Appropriate percentage for the 70% present value low-income housing credit: **7.53%**
- Appropriate percentage for the 30% present value low-income housing credit: **3.23%**

Note: Under section 42(b)(2), the applicable percentage for non-federally subsidized new buildings placed in service after July 30, 2008, shall not be less than 9%.
